Overview of the Court's statistics in 2023

The Court's statistics for 2023 disclose a decrease in the number of incoming applications allocated to a judicial formation. This can be explained principally by a decrease in the number of allocated applications coming from Russia, Türkiye, Serbia and Greece.

A. New applications

In 2023, 34,650 applications were allocated to a judicial formation, an overall decrease of 24% compared with 2022 (45,500). 21,000 of these were identified as single-judge cases likely to be declared inadmissible (a decrease of 21% in relation to 2022). As in previous years, single-judge applications continue to be processed as soon as they are identified as qualifying for such a procedure. In addition, 13,650 applications were identified as probable Chamber or Committee cases (a decrease of 27% compared with 2022).

B. Applications disposed of judicially and pending applications

38,260 applications were disposed of judicially, a decrease of 3% in relation to 2022 (39,570). The number of applications disposed of exceeded the number of allocated by slightly more than 3,600. As a result, the stock of allocated applications pending before the Court decreased over the year, from 74,650 to 68,450.

C. Processing of applications

1. Pre-allocation

As at 31 December 2023, the number of applications pending at the pre-judicial stage stood at 4,000, a decrease of 36% as compared with the same date of the previous year (6,250). The number of applications disposed of administratively in 2023 was 10,600, a decrease of 26%. 60% of these files were disposed of for failure to comply with the requirements of Rule 47 of the Rules of Court (contents of an individual application). The remainder of these files were disposed of administratively because applicants had not submitted an application form within the time-limit set by the Registry.

2. Inadmissibility or striking-out decisions

In 2023, 31,329 applications were declared inadmissible or struck out of the list of cases by a single judge, a Committee, a Chamber or a Grand Chamber, a 12% decrease compared with 2022 (35,402).

The single-judge formation decided 25,834 applications in 2023, 16% less than in 2022 (30,585). This can be explained mainly by a decrease in the number of applications allocated to a single judge in 2023.

In 2023, 2,425 applications were struck out by a Chamber or a Committee, in a decision following a friendly settlement or a unilateral declaration, an increase of 10% (2,208 in 2022). Friendly settlements (1,801) increased by 5% (1,718 in 2022) while unilateral declarations increased by 27% (624 in 2023 as against 490 in 2022). In addition, 3,070 applications were declared inadmissible by a Grand Chamber, a Chamber or a Committee or struck out by those formations on other grounds (18% more than in 2022).

3. Communicated applications

In 2023, 16,623 applications were communicated (an increase of 144% compared with 2022, when 6,822 applications were communicated). Of these applications, 57% were lodged against Russia.

4. Judgments

Judgments were delivered in respect of 6,931 applications (compared with 4,168 in 2022, an increase of 66%). A large proportion of these applications were joined, with the result that the number of judgments actually delivered was 1,014, a decrease of 13% compared to 2022. Furthermore, 682 judgments (in respect of 6,386 applications) were adopted by a three-judge Committee formation (-14% compared with 2022). However, there was an 80% increase (6,386 compared with 3,554 in 2022) in the number of applications

decided in a judgment by three-judge Committees, which accounted for 92% of applications decided by means of a judgment (compared with 85% in 2022). This year the number of applications decided by means of a judgment reached yet another record figure if the 2017 *Burmych and Others* judgment is not taken into account (*Burmych and Others v. Ukraine* (striking out) [GC], nos. 46852/13 and 12,147 others, 12 October 2017).

5. Requests for interim measures (Rule 39 of the Rules of Court)

The total number of decisions on interim measures (2,634) decreased by 15% compared with 2022 (3,116). The Court granted requests for interim measures in 1,419 cases (an increase of 30% in relation to the total of 1,094 in 2022) and dismissed them in 359 cases (a decrease of 48% compared with 685 in 2022). 91% of the requests granted (1,297 requests) concerned immigration issues in Belgium. It should be noted that 94% of the requests granted concerned issues other than expulsion or extradition. The remainder fell outside the scope of Rule 39 of the Rules of Court.

D. Priority policy¹

The essence of this policy is to concentrate more resources on the most important cases, namely the cases falling within the top three categories (“priority applications”). On 31 December 2023, 20,334 applications were pending in these categories (a decrease of 15% from the beginning of the year). This result was achieved thanks to the high productivity in these categories in 2023. Indeed, 6,880 priority applications were disposed of judicially, an increase of 66% compared to 2022 (4,152).

The number of priority applications communicated to the respondent Governments increased by 222% compared to 2022 (3,138 in 2022 and 10,114 in 2023). The number of priority applications declared inadmissible or struck out of the list of cases by a Grand Chamber, Chamber or Committee increased by 20% (1,509 in 2022 and 1,805 in 2023). The number of priority applications struck out following a friendly settlement or a unilateral declaration increased from 666 in 2022 to 794 in 2023. The number of priority applications giving rise to a judgment increased by 92% in 2023 (2,643 in 2022 and 5,075 in 2023). Such high figures were made possible by the processing of applications against Russia. In 2023 more than 7,700 priority applications against Russia were communicated, and more than 3,700 applications ended in a decision or judgment.

E. Conclusion

The Court has implemented the strategy adopted in 2020 for more targeted and effective case-processing with the aim of streamlining the handling of both priority and “impact” cases (i.e. non-priority Chamber cases which address core issues of relevance for the State in question and/or for the Convention system generally). This strategy is aimed at enhancing the Court’s immediate impact and relevance for the applicants and in the member States and its ability to address core legal issues of relevance for the Convention system as a whole. On 1 January 2021 there were almost 18,000 applications pending in category IV. By 1 January 2024 around 14,100 applications remained pending in category IV, of which 270 were identified as having an “impact”. The strategy has undoubtedly resulted in more efficient handling of important yet non-priority cases. Since January 2021, 704 “impact” applications have been processed, with 255 resulting in a judgment (68 in 2023, 111 in 2022 and 76 in 2021), 59 declared inadmissible or struck out of the list of cases (18 in 2023, 21 in 2022 and 20 in 2021) and 390 communicated (67 in 2023, 87 in 2022 and 236 in 2021).

Chart 1 Applications allocated to a judicial formation per year

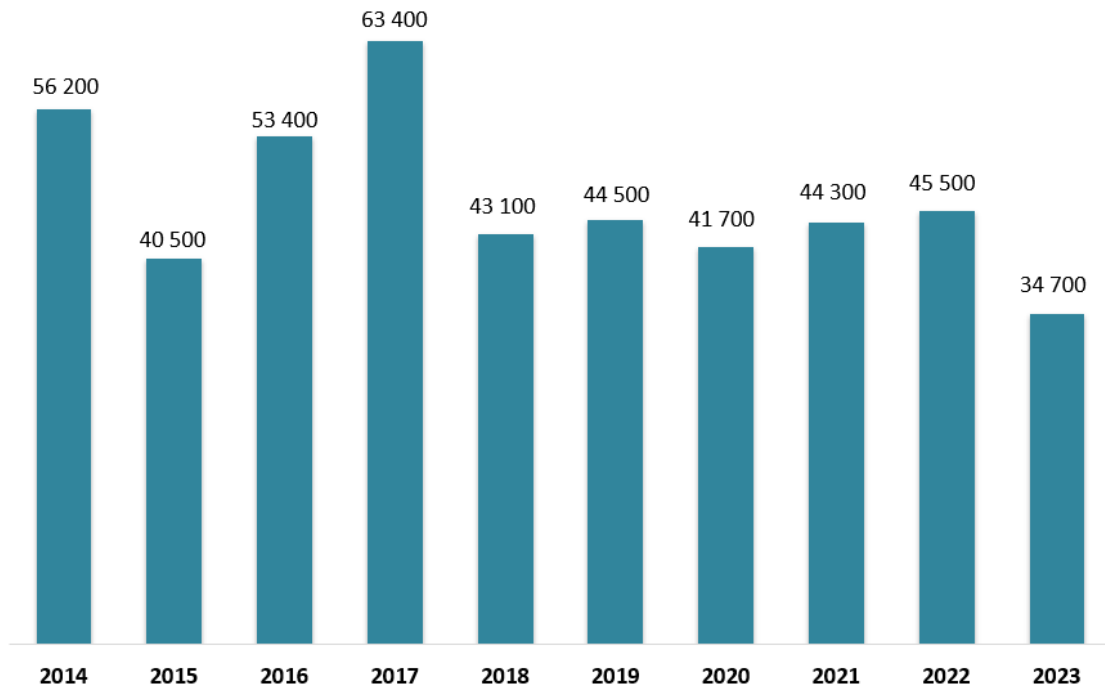
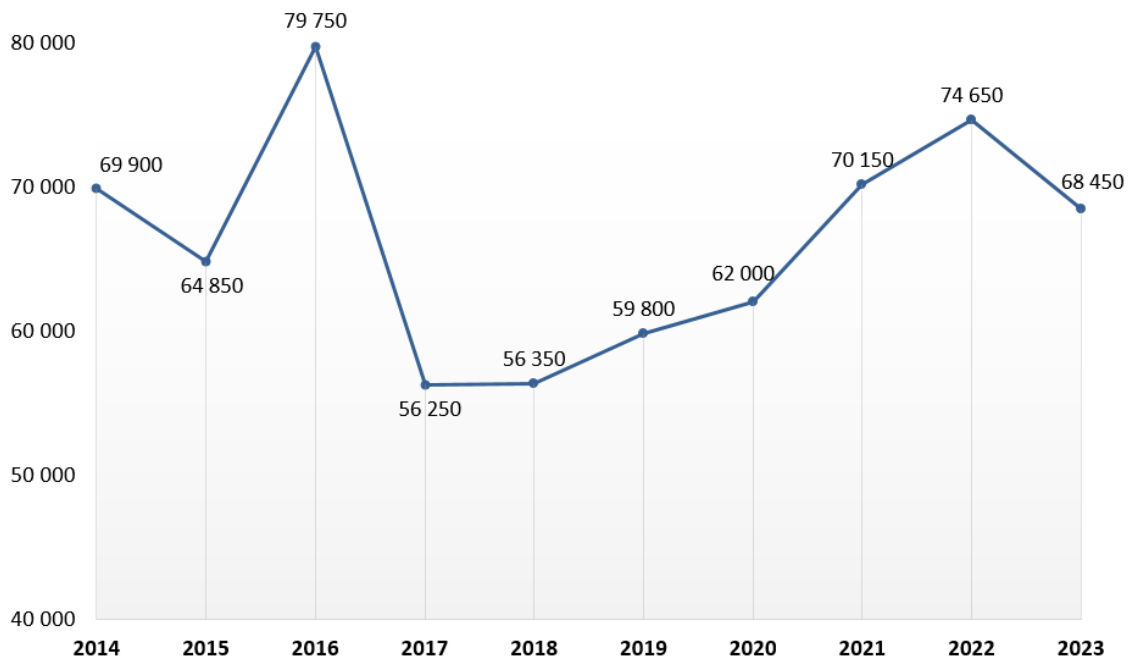


Chart 2 Applications pending before a judicial formation per year

Chart 3 Breakdown of 68,450 pending applications for the high case-count States

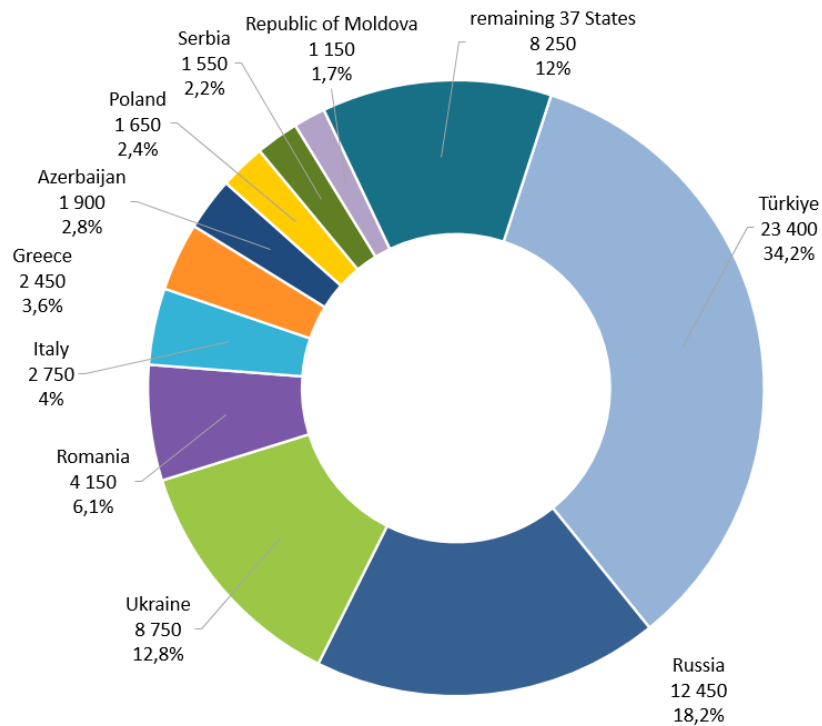
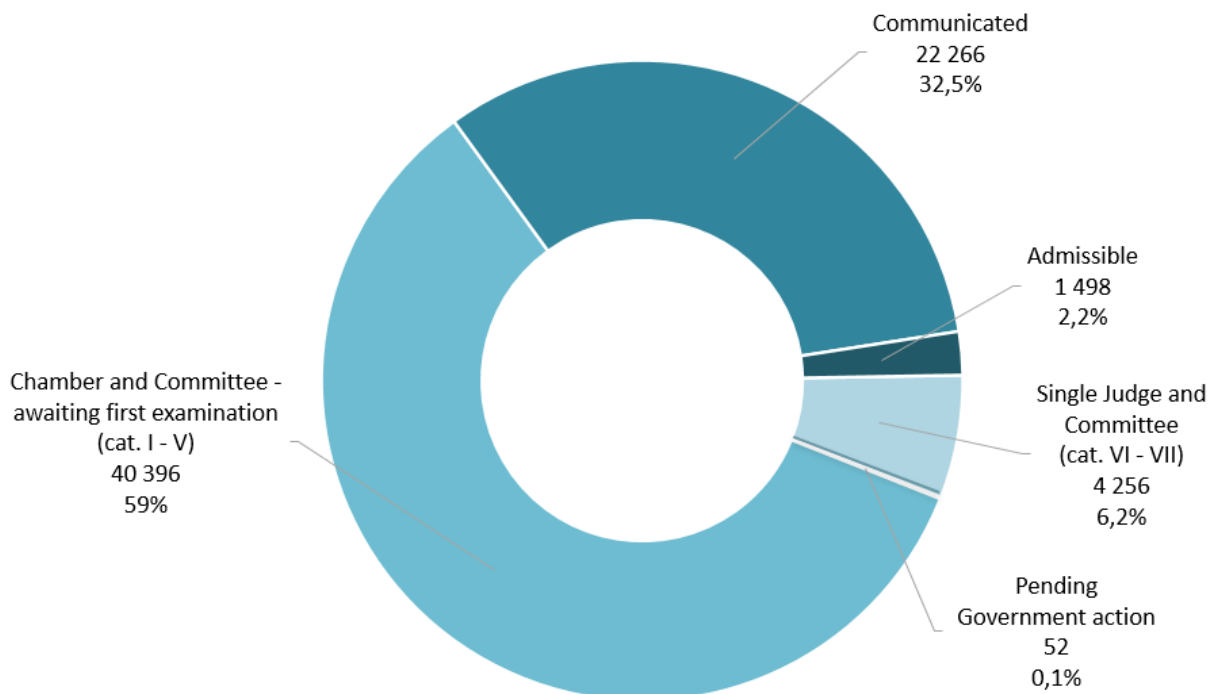
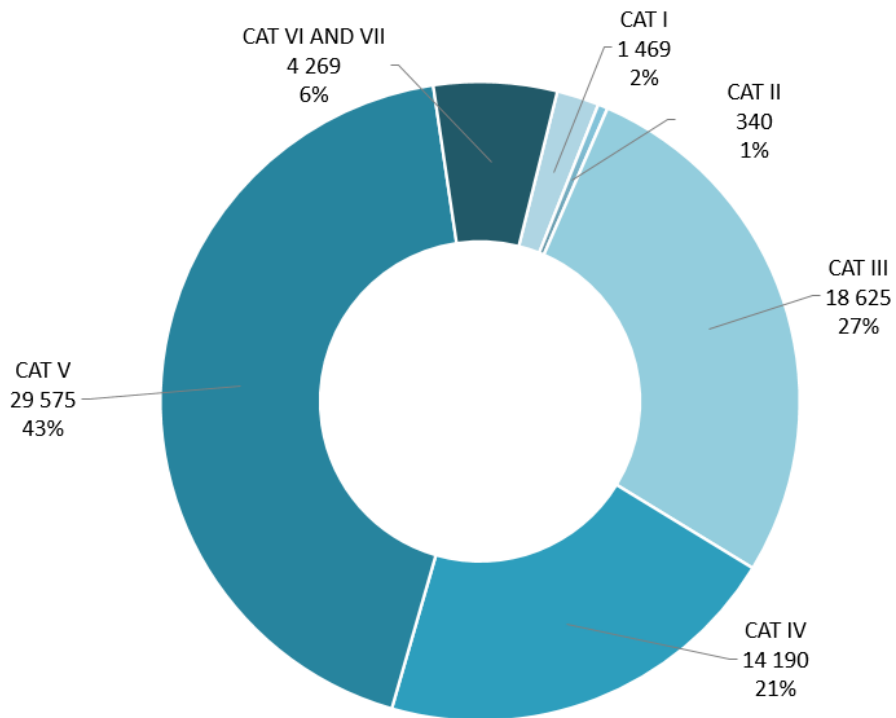


Chart 4 Breakdown of 68,450 pending applications by stage of proceedings and judicial formation³

Chart 6 38,260 applications disposed of judicially in 2023

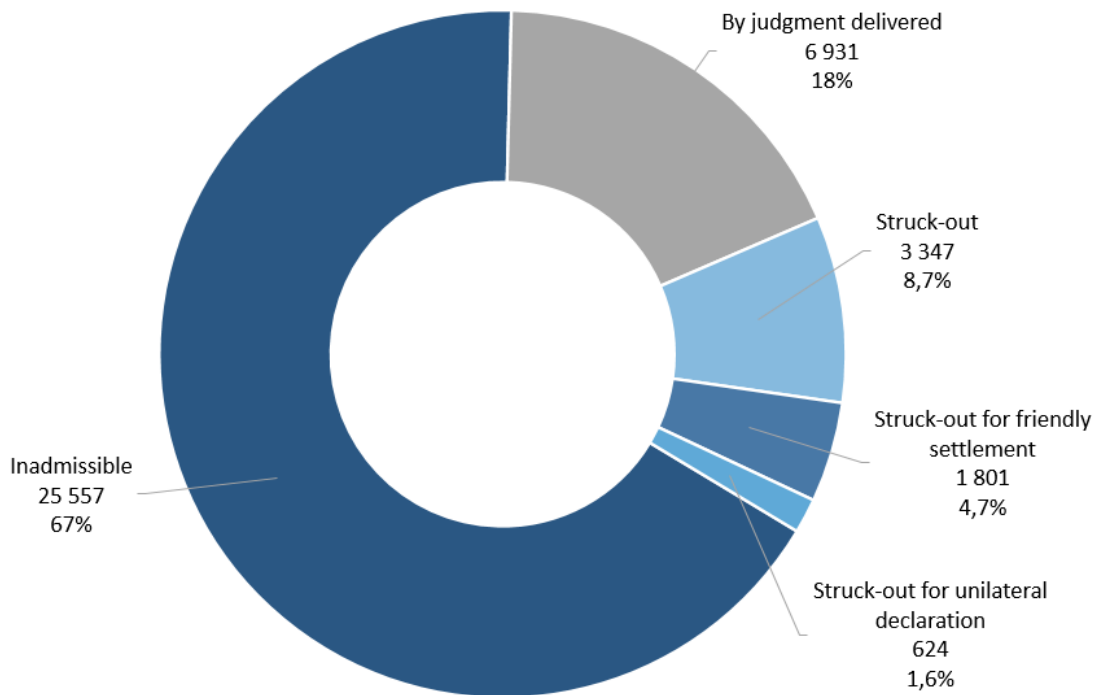
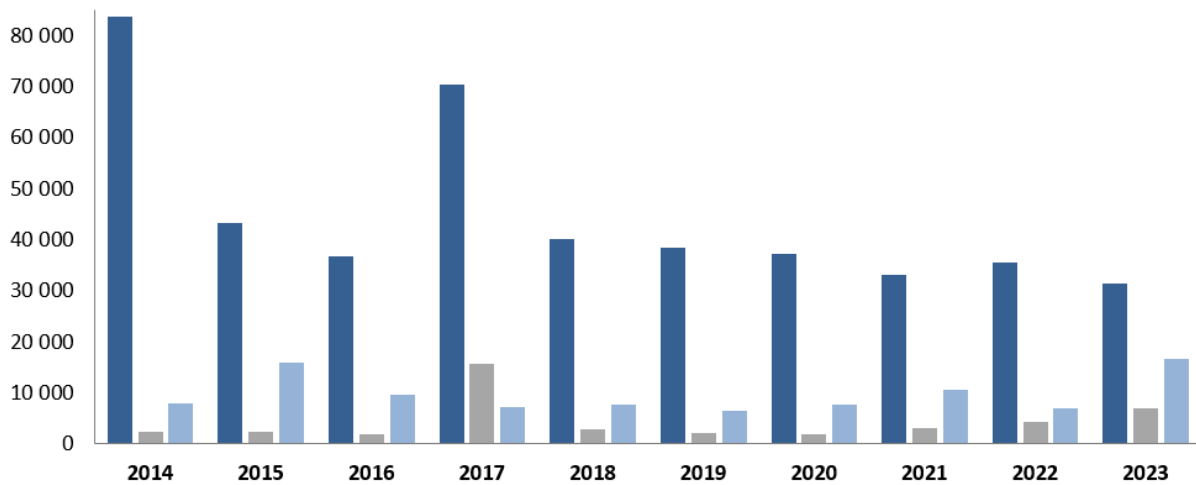
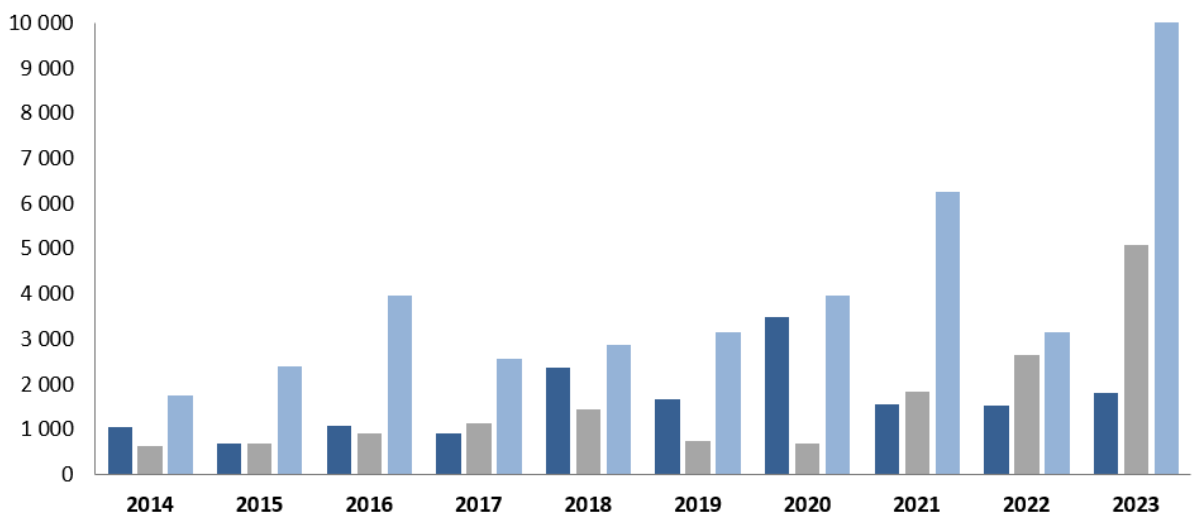


Chart 7 Applications in categories I to VII processed over the past ten years

Chart 9 Number of judgments (legal acts) over the past ten years

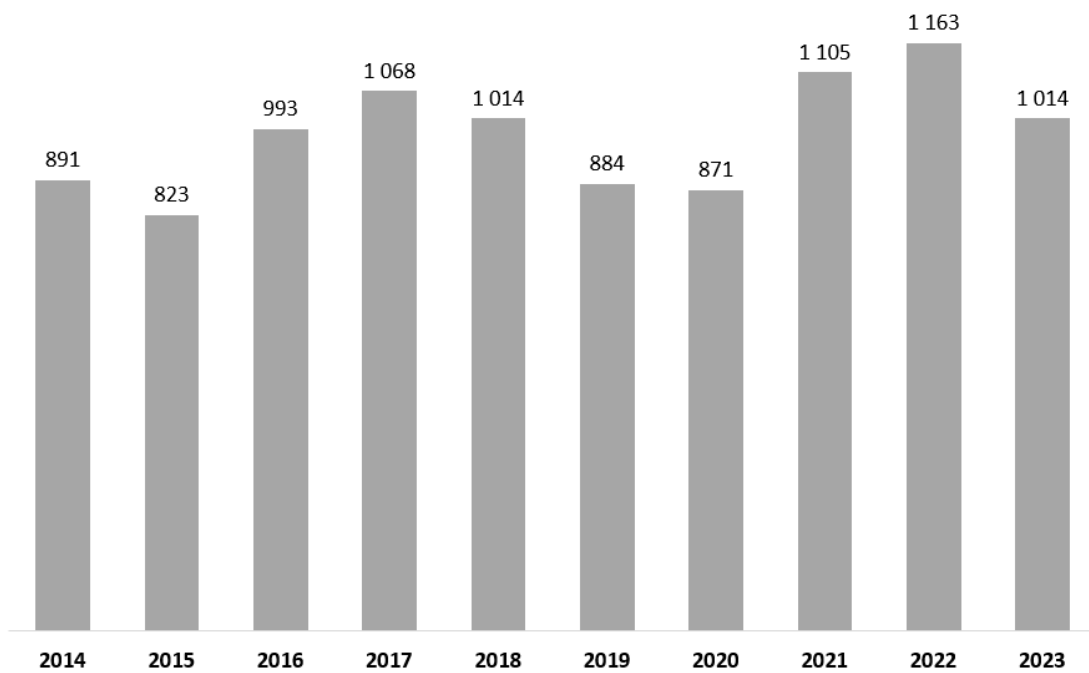


Chart 10 Evolution of the friendly settlements and unilateral declarations over the past ten years

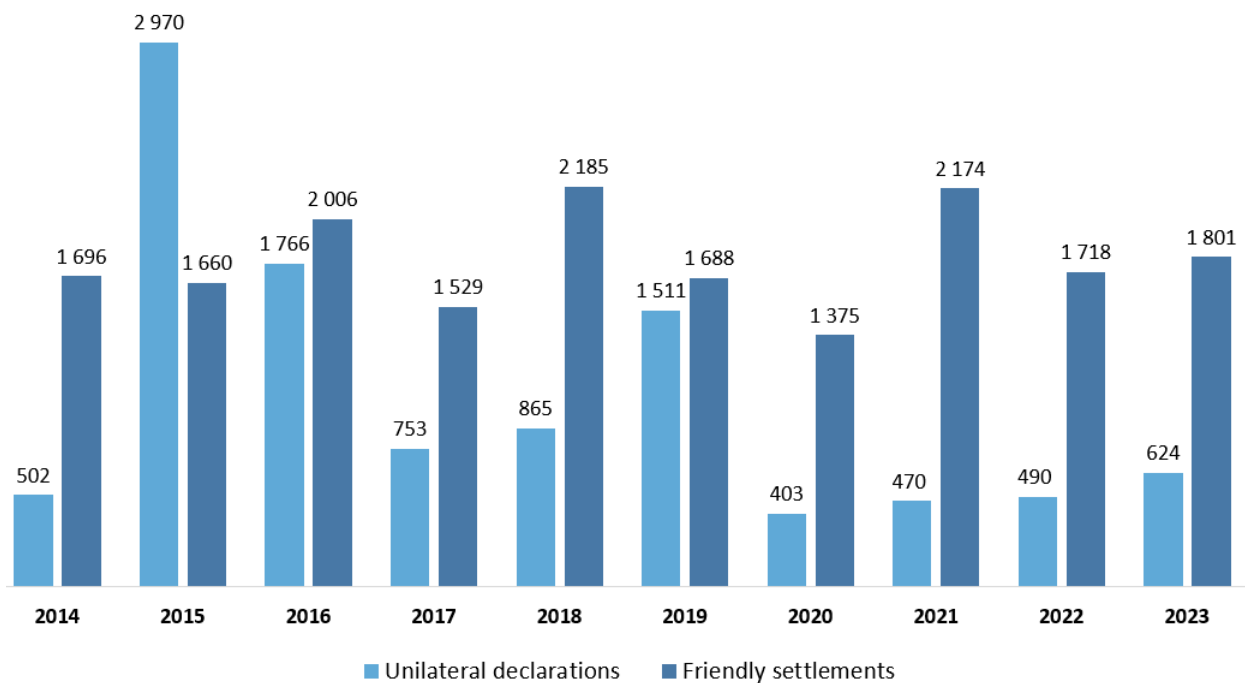


Chart 11 Applications by judgment delivered over the past 25 years

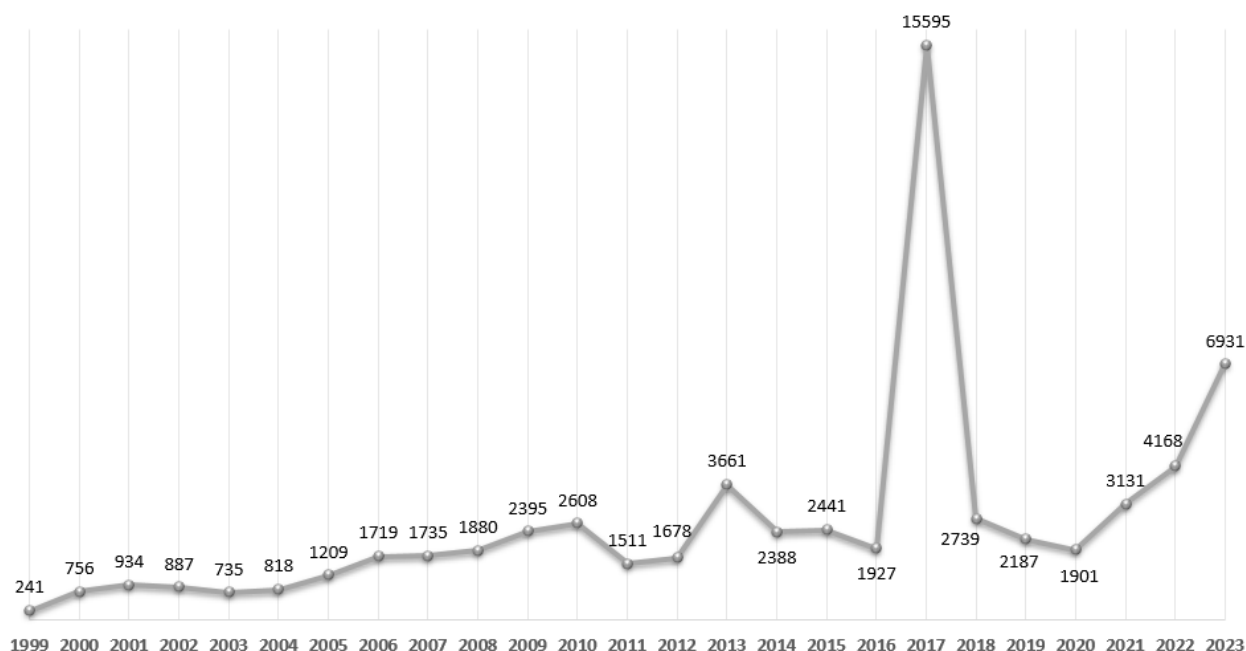


Chart 12 Applications inadmissible or struck out over the past 25 years

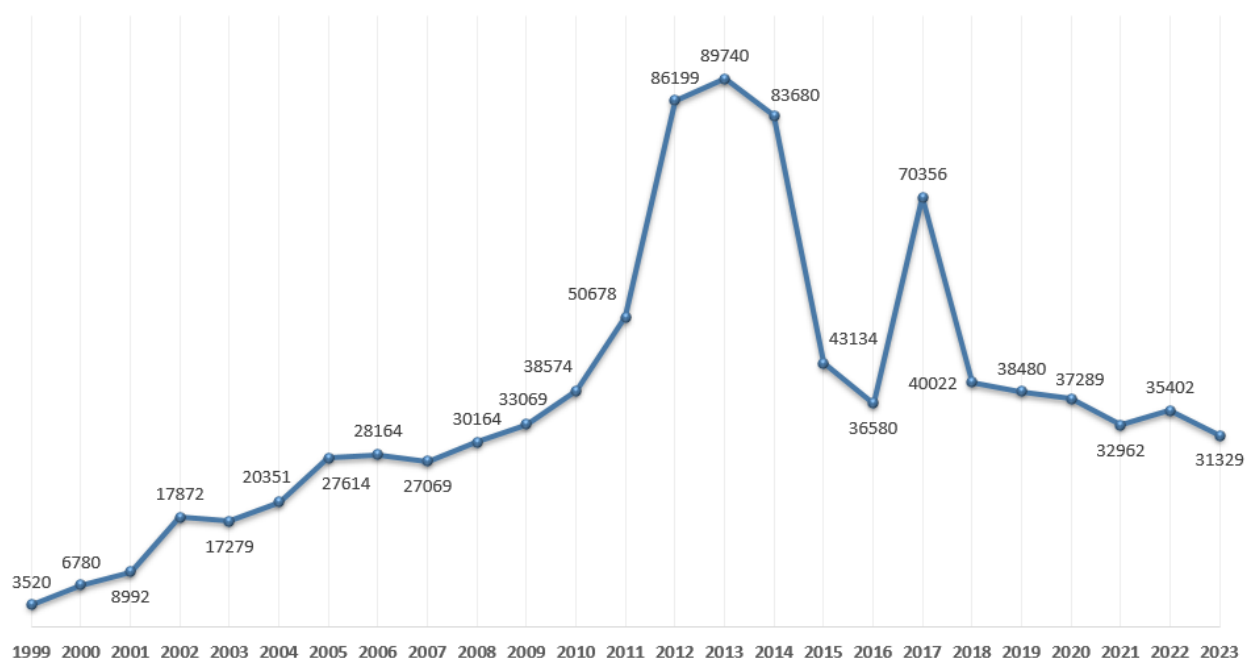
