II. Procedural History

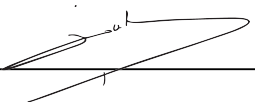

On 17 October 2025, the Chamber “invited Italy to provide information on any domestic proceedings relevant to the present case, and an indication of the impact that these proceedings could have on Italy’s future cooperation with the Court in the execution of cooperation requests for the arrest and surrender of suspects, by Friday, 31 October 2025 .”¹
3. On 31 October 2025, Italy transmitted its response via email and hard copy to the Registry.²
