

PACT FOR THE MEDITERRANEAN ACTION PLAN – SPRING 2026

Introductory note: preparation and regular update of the Action Plan

The EU Member States called for a swift and efficient implementation of the Pact for the Mediterranean (the ‘Pact’) through FAC¹ and EUCO² conclusions, in a spirit of co-creation, co-ownership, mutual interest and joint responsibility. The Pact was officially launched on 28 November 2025 in Barcelona in the presence of both EU Member States and the ten southern Mediterranean partners³. As planned, progress in its implementation is being presented and tracked in a **dedicated Action Plan**, which specifies the details of mature actions, specific deliverables, participating countries, stakeholders and funding for each initiative, as appropriate.

The Action Plan will be a living, rolling document. It will be **updated twice a year**, in line with the European Commission’s programming cycle and ahead of each meeting of the Joint Group at Senior Officials’ Level. **Prior to its presentation to the Joint Group at Senior Officials’ Level, the Action plan will be shared and discussed with relevant Council Working Parties, notably, the Mashreq/Maghreb Working Party (MaMa), as well as with the Heads of Mission of the southern Mediterranean partner countries in Brussels.** A **written update on the implementation of the Pact** drawn up by the European Commission and the EEAS will be submitted once a year in a timely manner for discussion in the MaMa Working Party, and with the Heads of Mission of the Southern Neighbourhood partner countries before the Joint Group at Senior Officials level. This will serve as an input for the Council’s political guidance at all relevant levels, including by the Foreign Affairs Council as required, on the priorities of the Action Plan for the following period and as input for the subsequent EU-Southern Neighbourhood Ministerial meeting.

The regular iterations of the Action Plan will **include only those initiatives and actions that are sufficiently mature to be launched for implementation in the course of the year**, while striving to maintain a geographical balance as well as a balance across the three pillars of the Pact. Amid an increasingly volatile geopolitical and economic landscape, compounded by persistent instability, the Pact will aim to remain relevant vis-à-vis current developments in the region, allowing for more focused work depending on the strategic and operational necessities of the EU and its southern Mediterranean Partners.

Their implementation will be supported with dedicated communication activities to ensure high visibility, applying comprehensively both online and offline tools and targeting all relevant audiences.

The Action Plan **is therefore not a new political document for formal adoption, but an operational, technical tool** for monitoring progress in the implementation of the Pact, promoting scalability and synergies. **It does not alter the existing adoption procedures for**

each initiative / action supported with EU funding. They will continue to be **carried out through relevant existing programming and adoption procedures** under the applicable multi-annual financial framework; cooperation in the field of security and defence will take place in accordance with the existing EU frameworks. Similarly, **initiatives and actions led by EU Member States or southern Mediterranean partners – and financed through their own resources** - will be implemented in accordance with the respective **national procedures and processes.**

Each 'box' includes the following sections:

- **Title:** corresponds to the wording adopted in the joint communication on the Pact for the Mediterranean. In some cases, the title mirrors only related sub-actions concerned by implementation (e.g. StartUp4Med). When no title is included in the box, the implementation relates to the initiative as a whole (e.g. T-MED).
- **Description of the action:** provides an overview of the objectives and the activities to be carried out.
- **Main deliverables and indicative timeline:** indicates key outcomes to be delivered over the course of 2026.
- **Funding:** indicates source of EU funding (adopted or indicatively planned), as well as additional sources of funding coming from EU Member States, southern Mediterranean partners or – at a later stage - third countries involved under 'triangular cooperation'.

PILLAR I - PEOPLE: THE DRIVING FORCE FOR CHANGE, CONNECTIONS AND INNOVATION

HIGHER EDUCATION, VOCATIONAL TRAINING, DEVELOPMENT OF SKILLS, RESEARCH AND INNOVATION

Establishing a Mediterranean University, which will be an institution with campuses in the Common Mediterranean Space [...].

Description of the action: *The action aims to position the Mediterranean region as a centre of transnational education and research by fostering stronger cooperation among universities and academics from all Mediterranean shores. It will result in the creation of a consortia of universities, coordinated by a Secretariat and will boost educational collaboration throughout the region. It will lead to strengthened university networks, the development of joint programmes and joint micro-credentials, and enhanced academic connections, promoting the mobility of students, staff, and researchers. Additionally, a feasibility study will explore the establishment over time of a full-fledged transnational institution with campuses on all sides of the Mediterranean.*

Establishing and further developing Innovation and Research Centres, bringing together universities and the private sector to improve knowledge and technology transfer involving innovators, startups and investors.

Description of the action: *The action will foster scientific collaboration, skills development, and competitiveness across the region. It will strengthen innovation by building partnerships between research centres, universities, experts and the private sector while reinforcing links between researchers and the industry. Starting with a dedicated Scalability Strategy, the initiative will replicate and expand the Innovation Fair format (pitching to potential investors, open innovation challenge, incubation opportunities) ensuring that research results evolve into scalable, market-ready solutions. In the longer term, the action will support the creation of a "MED Innovation Platform", a one-stop hub connecting innovators, researchers, entrepreneurs, and investors, and helping bridge the gap between research and market uptake. By promoting research-to-business initiatives, de-risk early-stage investments, the action will also help upskill young talent through a dedicated Deep Tech Transformation Training Scheme.*

BRIDGING THE SKILLS AND QUALIFICATION GAP IN LABOUR MARKETS

Supporting the development of schemes modelled on Youth Guarantee National Plans tailored to regional and local contexts to ensure that young people find opportunities in labour markets.

Description of the action: *The action will support the socio-economic inclusion of youth, particularly those not in employment, education or training (NEET), who represent 30% of youth in the southern Mediterranean region. The action will take inspiration from the EU Youth Guarantee model to support responsive policies, dedicated outreach and an integrated offer of education and training including on the job training, and access to employment or entrepreneurship, with a particular focus on the gender dimension.*

Establishing a MED Skill Tracker to document the skills acquired by beneficiaries of EU or partners' projects [...].

Description of the action: *The action aims at addressing a critical gap in documenting and recognising skills by effectively supporting the transparency, comparability and portability of skills, competences and knowledge of people in the region with the aim of ensuring a smooth transition to, and within, labour markets and enhance competitiveness. To start with, the action will focus on two components: 1) For national labour markets, the action will support the delivery of digital credentials for learning opportunities, targeting particularly youth, women and vulnerable groups. It will promote the use of tools such as the ESCO (European Skills, Competences, Qualifications and Occupations), Skills Observatory and data portals. 2) For the EU labour market, the action will also promote mobility notably through the use of Europass profile, analysis and comparison of qualifications in priority sectors ultimately contributing to scaling up Talent Partnerships and legal migration pathways, including through existing programmes (such as THAMM+) and the upcoming Talent Pool. The action will start by involving three southern Mediterranean partner countries in pilot projects and expand in time to other countries of the region. It will ensure full ownership by national authorities and training providers.*

Protecting and valorising cultural heritage [...].

Description of the actions: *The actions will support protection and revitalisation of tangible and intangible cultural heritage through the rehabilitation and promotion of cultural heritage sites and cultural landmarks, through a regional approach and aiming at i) enhancing (youth) skills and employment, ii) stimulating sustainable economic activity, iii) strengthening cultural roots and identity, and iv) promoting social cohesion. The action will also support several cultural expressions, including performing of visual and audiovisual arts, as well as contemporary arts. The actions will also develop activities promoting inclusion of women in the area of sports.*
